Our E-mail Differences

It has been brought to our attention that some of us have slow connections with outer space and some of us have faster ones. Some of us have small mailboxes; some of us larger ones.

Some of our members have received large ski trip picture files from friends who want to share. These files have been from 6.8 to 10 megabytes. Their mailbox holds only 10 MB. The result is that any mail coming in is returned and they have no way to tell who tried to contact them, if it was important or if the sender will resend the message. In addition, those files take tens of minutes to download.

MARVIN'S WEB POLICY ON PHOTOS. For each trip there would be one web page of "Web editor's choice" of photos with "link" to other web pages associated with each photographer. Reason: For the PVS web site, he has to "edit" photos for file size and sometimes brightness/contrast. He doesn't want to have complaints about excessive loading time for dial-up modern viewers. Often he receives many photos and will allow as many as he can comfortably edit. The main limitation is organization of the photos. There are links to each trip.
