### Candidate for PVS Vice President

## Meeting Announcements and Previous Meeting Review

### **John Brunelli, Candidate for ExCom**

A native of Franklin, Massachusetts, Rear Admiral John Brunelli is a graduate of Boston College. He received his commission from the Navy's Officer Candidate School in Newport, Rhode Island. Rear Admiral Brunelli was promoted to Rear Admiral Upper Half in August 1999.

During his career he has served in numerous sea duty billets including First Lieutenant in USS PHILIP (DD 498), Operations Officer in USS JOHN R. PIERCE (DD 753), Executive Officer, USS JOHNSTON (DD 821) and Chief of Staff for Commander, Destroyer Squadron Thirty. In 1983 he was selected to command USS OLIVER HAZARD PERRY (FFG 7), the lead ship of the Navy's largest class of guided missile frigates. From 1988 to 1990 he was the Commander of Naval Surface Group Four in Newport, Rhode Island, a command consisting of 17 ships and three shore based activities. He served several shore tours in Washington DC and received a Master of Science Degree in Financial Management from the Naval Postgraduate School, Monterey, California.

His awards include the Distinguished Service Medal, the Legion of Merit (four awards), Defense Meritorious Service Medal, Naval Meritorious Service Medal (three awards), Navy Commendation Medal, Combat Action Ribbon (for duty in the Gulf of Tonkin and Vietnam), two Battle Efficiency Awards and various other service and campaign awards.

Since leaving military service Mr. Brunelli has begun a second career as a consultant in the diverse fields of the privatization of military housing and software solutions applications.

A life long "intermediate" skier, John has joined PVS members on several trips to the west, Europe, and Whitetail which convinced him to cease east coast skiing.

### **Dick Schwartzbard, Candidate for ExCom**

Dick learned to ski on a small bump of ice otherwise known as a Pennsylvania ski resort. Since joining PVS in 2000 he has moved on to more formidable slopes as he participated in more than 20 western PVS trips. He credits his skiing ability to his desire to keep up with his wife Rosemary, a somewhat daunting challenge. Dick is a retired Federal employee, a fact that makes him not at all unique in our club. What does make him somewhat different, though, is that this will be his second time serving on ExCOM as he previously served a full term a few years ago. Dick is a long time Washington area resident and currently lives in Arlington.

### **Mary Beale bio Candidate for ExCom (continuing as Secretary)**

For years before I joined PVS, I heard about the Club through my mother Lu Beale. She was, I think, its biggest fan. Several weeks before a ski trip she would get out her duffel bag and begin packing. By doing so she could draw out the excitement. When she wasn't packing or working towards a TOOT deadline, she was planning the next "great hike". Her favorites were Sugarloaf, the Catoctins, Old Rag, and the Billy Goat trail. In her later years, the Gold Mine trail was the perfect length and slope. The family dachshund, members of PVS, and I were frequently invited along. These were fun times. They offered opportunities for starting new friendships and strengthening old ones. Occasionally more renowned trails were tackled- Little Devil Stairs and White Oak Canyon/Cedar Run among them. When I joined PVS in 2005 it was with the memory of these wonderful hikes and the warm camaraderie within the Club. I tried to ski but I soon concluded that I was a safety risk both to myself and others. In 2006 I officially retired after 35 years of practicing medicine. ## Jackson Hole, Wyoming Ski Trip; February 18-25, 2010

Our Jackson Hole trip started off with the usual excitement of a PVS ski trip, but even more so because of the hype inadvertently instilled by co- trip leader, Dottie Villers, who emailed us with daily words of wisdom about the trip, since we were **snowed out** of our pre-trip party **twice**. The flights and subsequent bus trip got all 37 of us to Jackson Hole in a timely fashion by 2:30PM with two exceptions. Dave DeVilbiss had to hop a later flight when the car wouldn't start after he and Carolyn had checked their bags. He arrived happily at Jackson Hole around 9:00PM that night. Greg Gell was also delayed due to a security alert on one of the legs of his flight.

Everyone settled into their rooms at the Alpenhof and at 5PM the hotel entertained us with their welcome party with cheese and chocolate fondue accompanied by hot gluhwein.. The Jackson Hole Mountain Resorts rep filled us in on the mountain, city of Jackson, answered questions and signed us up for the next morning's Mountain Tours.

For our first day most of us did the Mountain Tours led by ski instructors or ambassadors to help acquaint us with this magnificent mountain. Although not as high an altitude as other ski areas, the 4,150 vertical foot drop made for quick and interesting adjustments on the mountain. Many of us found out that the Jackson Hole reputation was true—their double blues (didn't know there was such a thing before) were like blacks at most other ski areas.

Unfortunately there were 2 injuries on the 1<sup>st</sup> day. Jack Chapman had a mishap at the top of lower Moran and blew out his ACL and MCL. He still had a smile on his face as he made his way around on crutches until Tuesday, when he and Ellie left. Dave Lerner got caught by the "snow snake" as he was maneuvering his way down the moguls on a double black diamond. He opted to have surgery on his right heel the next day but needed more surgery when he returned home. Reg Heichue was his "guardian angel" for the remainder of the trip, and David was able to continue to enjoy the many social aspects.

Snow showers came on Friday, Saturday and Wednesday which really helped the ski conditions through the week. Although still cold, the sun came out 3 days so we could appreciate the beauty of the Teton Village both from the Village and the top of the mountain via tram ride. Many of our advanced skiers skied down the Rendezvous Bowl, each with their own fantastic style. I'm told that Bob Knopes skied it unintentionally the first day, but was never the worse for it.

On Tuesday a group of 22 of us took the one hour plus bus ride over Teton pass to ski at the Grand Targhee ski resort. This is a smaller ski area than Jackson Hole, but

one which is renowned for its powder. Some might add that it's an easier mountain, but you might ask those who tried the Good, the Bad, and the Ugly – three black diamond trails. We had no fresh powder, but we did have a "bluebird day" with lots of sunshine and blue skies. On the way back our friendly and somewhat eccentric bus driver, Jesse, entertained us by singing for us. He also obliged us by stopping for a group photo with the spectacular Grand Teton mountains in the background. Note: Dave DeVilbiss accidentally, on purpose, forgot his ski boots at Grand Targhee—since he wanted new ones anyway he never went back to retrieve them.

Ten attendees also enjoyed the day long Yellowstone Tour, either by Snowcoach or Snowmobile (the later for the warm blooded). It included a viewing of the Old Faithful geyser doing her thing like she's done forever plus various other hot springs, water falls, continental divide sites and scenic lakes and streams. The ride over and back with views of the Grand Teton Mountains was just as glorious. See the web site for additional photos.

For many of us this was our first visit to Jackson Hole, and therefore a day in Jackson was definitely in order. We arrived by city bus to the Town Square designated by four arches made of elk antlers and lighted with Christmas lights at night. After some window shopping we met for lunch at the Bunnery, a perfect gathering spot with delicious brunch offerings. Then later that afternoon 16 PVS'ers took a trip to the National Elk refuge via sleigh ride. They saw lots of elk to whom they were introduced by their personal first names: Cyclops, Tiger Woods, Dumbo, Tom Brokaw, and use your imagination.....

Of course any PVS trip wouldn't be complete without the camaraderie enjoyed at our two après ski parties, one complete with the movie "Swift, Silent and Deep". Our dinner at the Gun Barrel with its western motif was delicious and appreciated by all, but that chocolate dessert took the prize. The town bus even cooperated that evening by picking us up within 10 minutes of our waiting in 10 degree temps.

The finale of the trip included with a scrumptious dinner at Snake River Lodge where Dottie and Marty were presented with two lovely pieces of jewelry (hand picked in Jackson by, of course, Rosemary and Eloise). A huge **Thank You** was offered to co-trip leaders Marty Rine and Dottie Villers, who did a great job handling our large, diverse group of skiers. The Jackson Hole trip will be a memorable one packed with a wonderful variety of activities and great skiing, including cross country for some.

### **Nat Seeman Skier and Physicist**

**April 19, 1923 - March 2, 2010.**

Although Nat only joined PVS in 1992, he got hooked on skiing earlier in 1964-65 when he took he and his family (wife and two daughters) off to Kitzbuhel on a two-week "learn to ski" holiday. Members of PVS remember him as an avid skier, who was elected a member of the PVS ExCom. On one occasion he assumed leadership of a ski trip on the spot after the designated leader was unable to continue. In fact he continued his skiing into the 21<sup>st</sup> century and remained a member of PVS until 2009. Even after he had "retired" from the sport he still joined a PVS ski trip for the ambiance. On a personal level, his devotion to Mary Jane McCarthy, a fellow PVS member and a Club President, continued well after she developed a serious illness. This was just one more indication of his personal qualities which endeared him to those in the Club who knew him.

Most PVSers were primarily acquainted with Nat as a skier and member of the Club. He graduated from Brooklyn College and served in World War II as a radio and radar specialist. After the war he returned to school for graduate studies at the University of Illinois where he received his MS degree in Physics. Then he came to Washington at the end of 1947 to get married, to start work at the US Naval Research Laboratory

and to continue graduate studies at the University of Maryland. At the Naval Research Laboratory he was associated with a well known group who were involved in the study of cosmic rays. The primary cosmic rays are high energy particles (mostly protons from outer space which collide with nuclei of molecules in the earth's atmosphere resulting in transitory new particles (such as the muon – intermediate in mass between an electron and proton.) It is not easy to investigate the nature of cosmic rays. Nevertheless, Nat and other members of this group have made a number of significant contributions to the field. Nat also developed a strong interest in black and white photography, built a large darkroom, and competed in area-wide club competitions.

On a personal level, Nat lost his first wife to cancer in 1973. His survivors from this marriage include two daughters. A graveside service was attended by PVS members John and Ellen Burgess, Ray McKinley, John Brunelli, Betty Byrne, and Marvin Hass. With his passing, his family, his skiing companions, and the community have indeed lost a true friend and gentlemen.

The Yellowstone Club, a 13,600-acre playground 20 miles north of Yellowstone National Park, may be the world's lone members-only ski resort. Its pristine natural beauty and remote location have attracted wealthy skiers who prize their privacy, including [Bill Gates](#) of [Microsoft](#); Barry Sternlicht, the hotelier; and [Peter Chernin](#), president of the [News Corporation](#).

Membership has its price: a minimum of \$250,000 to join, plus the cost of a \$5 million to \$35 million mountainside home, plus annual dues of about \$20,000, according to members.

Marketed with the phrase "Private Powder," Yellowstone is the anti-Aspen — luxurious, sure, but discreet and child-friendly. Ask members what makes it so special, and more than one offers this simple fact: There, and nowhere else, the family of the world's richest man can ski without bodyguards. One club member — who, like many Yellowstone members, requested anonymity so as not to be seen as violating the club's tradition of not blabbing about one another — recalls Mr. Gates's saying that his family once tried Vail but their need for security "made us look like jerks. Here, we don't need it." That's because the club has long been kept safe by former Secret Service agents, and who can put a price tag on that?

In one of the signature, fin de siècle moments of our passing Gilded Age, the Yellowstone Club filed for Chapter 11 protection last November;.
