## **SKI TALK**

### **July 2021**

Life is beginning to feel more normal. We are going out more; meeting friends; going to restaurants; planning trips. We were hoping to have definitive information on our Snowmass trip by this time, but that is not to be. We are in close contact with the new owners of Mountain Chalet in Snowmass, and they assure us they will be open next ski season. Our vendor, Doug Horstman, from Encompasse Tours, is in the process of working out a contract for our club, but it is not finalized in time to be included in this TOOT. We will send a blast email once details have been worked out. In the meantime, we strongly encourage you to let Kathy Lake know if you are planning on going. See her email address below.

### **TRAVEL INSURANCE**

It is more important now than ever to take out travel insurance. We **STRONGLY** recommend that everyone accept coverage. With pricing starting at just 7% of your trip cost, protecting your investment is a reasonable thing to do. Claims on ski trips are significantly greater than typical travel packages for logical reasons. Skiers confront weather delays, cancellations, the peak of the flu/covid season, and occasional injuries sustained by participating in an active sport. You may want to start your research. Most companies have at least three levels of coverage. Cancel for any Reason is the most expensive but often only covers 70-80% of the trip. If you do decide on Cancel for Any Reason, you will need to sign up for insurance within a week or so of putting a deposit on the trip. In this era of Covid, here is some information from the AIG/Travel Guard website, which is the company our vendor uses.

### **Am I covered, if I contract COVID-19?**

If you contract COVID-19 prior to your departure, you may be covered for Trip Cancellation if there is a confirmed diagnosis, including proof of illness from your doctor that states you are medically unable to travel at the time of departure.

If you become ill with COVID-19 while on a covered trip, you could be covered for Medical Expense, Trip Interruption, Trip Delay, and Emergency Medical Evacuation benefits if there is a confirmed diagnosis, including proof of illness from a doctor.

- Trip Interruption can provide coverage for the unused portion of your prepaid and non-refundable expenses, as well as additional transportation expenses incurred to return home or rejoin your trip.
- Trip Delay can provide coverage for additional expenses you may incur for hotel, meals and certain transportation costs incurred if you are required by a physician to quarantine.
- Medical Expense and Emergency Medical Evacuation can provide coverage for medical expenses incurred while being treated for COVID-19.

These coverages are subject to the terms and conditions of your insurance policy.

### **What happens if I am traveling to a country that requires a COVID-19 test when I arrive, and I test positive?**

AIG/Travel Guard is treating COVID-19 like any other unexpected illness. When you arrive, if you test positive for the virus, you could be eligible for coverage. If a doctor requires you to be hospitalized or quarantined, you could be eligible for Trip Interruption, Trip Delay, Medical Expense and Emergency Medical Evacuation coverage. A confirmed diagnosis and proof of illness from a physician is required. Coverage is subject to the terms and conditions of your insurance policy

## **I want to cancel my travel plans because I'm afraid to travel due to the COVID-19. Am I covered?**

Trip cancellation that is due solely to concern or fear of travel related to an epidemic or pandemic, including COVID-19, is not covered.

Purchasing travel insurance is super easy. If you are going on the Snowmass trip, each participant can obtain and pay for coverage by going to the website of our vendor, [www.encompasse.com](http://www.encompasse.com), clicking the "TRAVEL INSURANCE" link on the grey bar at the top of the page, and registering online with AIG/Travel Guard. Be sure to identify Encompasse as the booking agency at the appropriate spot on the registration form so that AIG/Travel Guard can certify the policy and interact with our vendor in the event of a claim. Please read your policy for details of coverage. If you have questions pertaining to your policy contact AIG/Travel Guard at 1.877.249.5376 (U.S. Toll Free).

### \*FYI

**Absentee Member** must be a former Active Member, must have their primary residence greater than 75 miles from Washington, DC, and may not vote nor hold elective office. Those members qualifying for Absentee Member status may change their membership category at any time. Also, they may continue in or change to Active Member status. **Associate Member** must have a primary residence greater than 75 miles from Washington, DC. Similar to an Active Member, he/she must be sponsored by an Active or Absentee Member, attend at least one PVS event, and be approved by members at the annual meeting. Also, an Associate Member may not vote nor hold elective office. Associate Members do not count toward our 200-membership limit. Unlike an Absentee Member, an Associate Member never has been an Active Member and, therefore, cannot change back to Active Member status.

Here are the books we shared in June:

- Ellie Thayer has been reading "The New Ireland: How Europe's Most Conservative Country Became Its Most Liberal Country." Author Niall O'Dowd notes how abuses of the Catholic Church in Ireland led to an upheaval in social thought in the country.
- Mary Ellena Ward brought us the charming "The Complete Wizard of Oz Collection" that presents the 15 children's books about the mythical land of Oz, written by L. Frank Baum.
- Marianne Soponis has extended her reading of Anthony Horowitz by enjoying "Moriarty" which imagines a time when Sherlock Holmes meets his nemesis at Reichenbach Falls in Switzerland and tragedy ensues.
- Bonnie Sweeney, in her "regular" book club, has been reading "This is How It Always Is" by Laurie Frankel, a fictional account of how a family dealt with a child's transgender status.
- Jan Marx has begun "Apeirogon" by Colum McCann, about a Palestinian and an Israeli who become friends. She is concurrently reading "Surfacing," a novel by Margaret Atwood about discovering oneself through a journey through the protagonist's past in Quebec.
- Karen Zill found "There There" by Tommy Orange illuminating. Orange is an urban Native American and he weaves together the stories of the lives of 12 seemingly disparate characters as they make their way to the Big Oakland Powwow in Oakland, California.
- Nancy McKinley discussed the value of historical fiction, having read "Wolf Hall" by Hilary Mantel. Mantel's meticulous research made for a fascinating picture of the early 1500s in England, the role of Thomas Cromwell, and the rise of Anne Boleyn.
